SPC Connect End User terms

These general terms and conditions shall apply on the right to access the Vanderbilt International SWE AB ("Vanderbilt") SPC Connect through web log in or downloading a mobile app.

SPC Connect (the "Service") is provided to installers of intruder alarm boxes ("the Installer") according to a separate agreement with Vanderbilt. According to the agreement with Vanderbilt the Installer is entitled to register its end users as users of the Service subject to that the end user accepts these SPC Connect End User terms.

By accepting these SPC Connect End User terms Vanderbilt will give You a right to access to the Service and the right to use the mobile app subject to these SPC Connect End User terms and You certify that You have read, understood and accepted the terms set out herein. You are hereinafter referred to the **End User**.

With **User Content** below means material (including without limitation, text, images, audio material, video material and audio-visual material) that the End User submits to the Service for whatever purpose.

1. THE END USER'S USE OF THE SERVICE

- 1.1 The End User has a non-exclusive, non-transferable right to use the Service for intruder alarm boxes installed by Installer at the End User as long as the Installer has registered the End User as a user. The mobile app may only be used to access the Service.
- 1.2 The End User may not duplicate or copy any images, name and branding of the Service or reuse any images, name and branding of the Service. User.
- 1.3 The End User must not use the Service to transmit or send unsolicited commercial communications or for any purposes related to marketing without the express written consent of Vanderbilt.
- 1.4 The End User must not use the Service in any way that causes, or may cause, damage to the Service or impairment of the availability or accessibility of the Service; or in any way which is unlawful, illegal, fraudulent or harmful, or in connection with any unlawful, illegal, fraudulent or harmful purpose or activity.
- 1.5 The User Content must not be illegal or unlawful, must not infringe any third party's legal rights, and must not be capable of giving rise to legal action whether against End User or Vanderbilt or a third party (in each case under applicable law).
- 1.6 The End User is required to follow the any written instructions provided by Vanderbilt for use of the Service.
- 1.7 The End User shall ensure that (i) the User Content is free of viruses, Trojans, worms or other harmful software or codes, (ii) the User Content is in the agreed format, and (iii) that the User Content cannot, in any other way, harm or adversely affect Vanderbilt's system or the Service. The End User must not use the Service to copy, store, host, transmit, send,

- use, publish or distribute any material which consists of, or is linked to, any spyware, computer virus, Trojan horse, worm, keystroke logger, rootkit or other malicious computer software
- 1.8 The End User shall ensure that log-in information, security procedures, and other information provided by Vanderbilt for access to the Service, is treated as confidential information. The End User shall immediately inform Vanderbilt in the event that any unauthorised person has obtained knowledge of information pursuant to this clause

2. INTELLECTUAL PROPERTY RIGHTS

2.1 Vanderbilt and/or Vanderbilt's license provider are the owner of all rights including intellectual property rights to the Service and the mobile app and other programs it includes.

3. RIGHTS TO USER CONTENT, USE OF GOOGLE ANALYTICS

- 3.1 End User grant to Vanderbilt a worldwide, irrevocable, non-exclusive, royalty-free license to use, reproduce, adapt, publish, translate and distribute the User Content in any existing or future media.
- 3.2 End User also grants to Vanderbilt the right to sub-license these rights, and the right to bring an action for infringement of these rights.
- 3.3 The Service also uses Google Analytics, a web analytics service provided by Google Inc. ("Google"). Google Analytics uses "cookies", small text files stored on End User computer to analyze how the user use the website. The information generated by this cookie regarding the user's use of this website is usually transferred to a Google server in the USA and stored there. Where IP anonymization has been activated on this website, your IP address will be truncated to only indicate that the address came from somewhere within the European Union or for other countries party to this agreement, within the European Economic Area. Google will use this information on our behalf to evaluate the use of Vanderbilt's website, to generate reports on website activity and other website and internet related services. The IP address transmitted to Google Analytics from your browser will not be merged with other Google data. End User may block the use of cookies by altering your browser settings; but Vanderbilt would like to point out that this may prevent End User or the End User from accessing all the features of our website. The User may also block the transmission of data regarding the End User's use of Vanderbilt's website (including your IP address) to Google as well as the processing of that data by Google by downloading and installing browser plug-in available at: https://tools.google.com/dlpage/gaoptout?hl=de.

4. NO LIABILITY

The End User is a user within a customer to the Installer according to an agreement with the Installer. ALL RIGHTS, RESPONSIBILITY AND LIABILITY FOR THE END USER'S USE OF THE SERVICE OR THE MOBILE APP IS GOVERNED BY AND REGULATED

These SPC Connect End User terms are governed by Swedish law, without regard to its conflict of law provisions.
